On-Board Driving Video Recording System

1 SCOPE

This Standard specifies the requirements and test methods of the on-board driving video recording system.

This Standard applies to the on-board driving video recording systems (hereinafter referred to as "the system") intended for the vehicles of Category M_1 , while the system intended for the vehicles of other category may use this standard as a reference.

3 TERMS AND DEFINITIONS

For the purpose of this document, the following terms and definitions apply.

3.1 On-board driving video recording system (DVR)

A system, which is installed in the vehicle, which displays, records and stores the vehicle front driving image in the manner of video streaming, and by which the video data recorded and stored are accessible

3.2 Frame rate

Number of frames producing complete image in unit time

Note: the total number of scanning video signal spatial lines in unit time, expressed in frame per
