Rules for the Inspection of Power-Driven Vehicles for Import and Export- Part 4: Motor Vehicle Products

1 SCOPE

This Part of SN/T 1688 specifies the technical requirements, inspection methods, sampling and pass/fail determination of motor vehicle products for import and export.

This Part applies to the power-driven vehicles which has four or more wheels, which is non-rail, and which is normally used for:

- carrying persons and/or goods (objects);
- towing vehicles used for carrying goods (objects) or for special purposes;
- special services.

This term also includes:

- a) the vehicles connected to an electric conductor, for example trolley buses;
- b) three-wheeled vehicles without a cab, whose complete vehicle kerb mass exceeds 400 kg;
- c) three-wheeled vehicles with a cab, whose complete vehicle kerb mass exceeds 600 kg.

3 TERMS AND DEFINITIONS

For the purposes of this document, the terms and definitions given in GB/T 2828.11 and SN/T 0002.1 as well as the following apply.

3.1

mode of sampling inspection

the conformity assessment activities by sampling, testing and inspections carried out for import and export commodities lot by lot or by skip lot according to the mandatory requirements of national technical specifications

3.2

mode of compliance verification

the conformity assessment activities used to check/inspect whether the documents and certificates conform to the goods according to the mandatory requirements of national technical specifications, where necessary, perform random inspection and implement supervision

3.3

inspection lot

a unit of products of the same specifications, same model and manufactured under same production conditions collected for inspections, abbreviated as lot
